Return:

Transfer of Ownership:

Ownership of the animal adopted from Dogs & Cats Forever, Inc. may **not** be transferred for any reason.

Under no circumstances will our dogs be dual-personality; protection or attack trained, agitated in any manner, or allowed to be used as a guard dog for any agency, firm, corporation, or organization. The animal must not be maintained outside, 24 hours a day, as the primary function of our animals is to be a house pet.

Reservation of Rights:

Dogs & Cats Forever, Inc. reserves the right to follow up on the adoption in order to protect the welfare of the animal. If the terms and agreements of this contract are not upheld by the adopting party, Dogs & Cats Forever, Inc. reserves the right to terminate this agreement and the adopting party must return the animal(s) to Dogs & Cats Forever, Inc. upon request.
